I hope that I have left the club in good shape by ensuring the bank accounts have similar balances to when I took over mainly due to the hard work of the Hon Secretary and Honorary Treasurer procuring government grants and furlough monies.

There are a number of challenges we face as a Club, and I would encourage you to use your bar and functions as much as possible.

Finally, I would like to thank our staff who have had a roller coaster ride during covid but have always kept the bar open when we were allowed.

Vice Commodore's Report

I submit this annual report at a time when once again we are very much in a period of great uncertainty with Covid 19 calling the shots.

This report covers in fact a period of 2 years but for obvious reasons will not be double the length!

There is little to say of my time as Vice Commodore as sadly with the club so often closed I was seldom called upon often to act in that capacity, but I will say a huge thank you and well done to the Staff and Members who were very active in keeping the club solvent whilst being forced to close. Being closed is not a cashflow halting situation, simply one that ensures the cash flows away. The choking off of that flow to enable us to be in a position to bounce back was a commendable achievement.

During this period I was also appointed as Chair of the Bar Committee, as is required by the Club Premises Certificate under which we currently operate. As you can imagine with the club so much closed the bar opening has been very adversely affected. The bar can open when the club is open and therefore staffed, it does not operate in reverse. However, we have over the past months taken the opportunity to open whenever possible and with any excuse! I thank those who very much supported the bar in October with events every weekend. The more the bar is used the more it can open, that is not unique - look at the licensed premises in the town and note just how many remain closed for many days of the week, something we aspire not to do. A full normal itinerary of events was planned for December, drinks, meals socials etc. As I write this, I can only hope they are supported fully.

As we were affected by Covid in 2020 our suppliers hit us with a price increase on alcohol and soft drinks which we did not pass on as we struggled to re-open. Sadly we have just been advised of a further increase of 6%. This is across the licensing trade and not unique to us. It is impossible for us to completely absorb this increase and inevitably in January bar prices will be seen to rise. I believe that no matter how unpleasant this is, hiding or disguising the fact would be much more so.

As we go forward and with Barry Stone having been promoted to Club Manager he will be given far greater opportunities to maximise the benefits that the club can gain from a fully operational hotel, bar and restaurant. From increased sales comes reduced prices!

Now on a totally different theme. Ramsgate illuminations 2020/2021 were an amazing success with the highest number of boats ever lit for Christmas. This year 2021/2022 is on track to once again fill the harbour with light and festive cheer and I sincerely thank every RTYC member who has gone the extra mile to light their boats.

Honorary House Officer's Report

Another two years in the position of House Officer, have again flown by. We have a beautiful clubhouse however the upkeep is a never-ending project. Despite the club being forced to shut for a large proportion of the last two-year period due to Covid 19 and the enforced lockdown, we have remained busy in the general maintenance and repair of the club house. I must say "thank you" again to Barry and all the staff, for their help and support throughout these strange times. Managing the day-to-day tasks, cleaning duties and general maintenance required in the clubhouse and for dealing with minor repairs and, many smaller "in house" jobs. We have employed Contractors and various sub-contractors for larger jobs, maintenance requirements and projects. During the year, the usual tasks have been carried out, such as the carpets cleaned regularly, the Kitchen has had a professional "Deep Clean, the annual check to the roof and guttering, safety testing of all the electrical equipment, and yearly Gas Safe testing on all gas appliances and the annual drain clearing. The regular cleaning of the silverware in the trophy cabinet, and various white goods have been purchased including a Tumble Dryer. We have also installed further security cameras to the building. The fire extinguishers have been upgraded, and a new RTYC Banner for the Balcony to be put in place in the spring.

Following the inspection from the KCC Fire & Safety Officer in late 2019, whereby some areas had been highlighted that required attention to again comply with the regulations. This work is now completed and from subsequent visits it appears we are fully compliant. There are constant changes to legislation and in April we had a spot check from Southern Water resulting in major works having to be undertaken to the club plumbing system in to comply with the current day regulations. There has also been various electrical works carried out to the door entry systems and the wifi in the clubhouse.

Over the 2019 – 2020 festive break we employed contractors to overhaul and upgrade the hotel bedrooms, this work included redecorating, replacing some furniture, carpets and curtains to all the bedrooms. The communal shower and toilet were also both remodeled. At the same time the electrics were inspected. The result of all this work was clearly shown in the great reviews by hotel guests once we were able to open again.

In early 2021 The Top floor flat was upgraded and completely redecorated in time for our new Housekeeper/General Assistant to join us. In the summer Scaffolding had to be erected for repairing brickwork to the front of the building carefully remove existing cement fillet & roof tiles as required and repairing balcony lead roof and damaged masonry. While the scaffolding was up it enabled access to the roof to obtain a report on its condition, this led to some immediate urgent repairs being carried out. However, it is an old building and the roof has been of some concern for many years, and it now appears we will expect to have a large outlay in the not too distant future to keep the roof in good repair. The "Roof Fund" that was put in place for future maintenance is still slowly growing. There has been a fair amount of repair and maintenance work to the exterior including work to the balcony, repairing the steps to the terrace, and painting the main steps with anti-slip paint. There has been a new drain drilled through to the corner of the terrace and connected to the existing downpipe to prevent further flooding of the terrace. During the summer of 2021 new patio furniture was purchased with the help of the 250 club. More recently it was found that due to leaking from old pipe work in the basement, the Gentlemen's toilets had to be upgraded. This work was long overdue however now all completed. Whilst the contactors were in the club several important repairs were also carried out including bricking up the old wooden outside cellar door which had completely rotted away. Repairing the gullies to the front of the club to prevent water coming into room 5., Clean off bird nests to the front of the building and repair the netting over the front door to further prevent the pigeons from nesting. Prepare and rerender the damaged sections of wall above doorway to Hold bar and fix helix-fix bars to retaining wall.

All works were completed by the contractors on time and within the allocated budget. The never-ending tasks of repair and redecoration of the building continues, with our ongoing improvement programme for 2022 already in place. Having been in the position of Hon House Officer for over 11 years, I think it is time to let someone else take over, so 2022 will be my last year in the post and hope that one of our members will be interested in taking up the reins.

In addition, thanks to much needed income from the government and the local council our overall income has largely met our outgoings. In fact, if we exclude the very significant early 2020 bill for Repairs and Refurbishments, we actually made a small profit.

As in recent previous years your office team led by our Honorary Secretary Elizabeth, our administrator Kathryn and our bookkeeper Zoe have kept control over income and expenditure allowing us to look forward with some confidence to the coming year despite all the obvious difficulties. Their hard work and professionalism deserves our grateful thanks.

Each of our fixed and variable expenditure items have been examined and minimised by the office team in line with our changed circumstances and necessary amendments have been implemented. Further work to reduce our necessary outgoings will be needed early in 2021 if we are to retain our good situation.

Our thanks must also go to our Accountants, Dudley Gore and Co., not just for the Auditing function but also for their not inconsiderable help navigating the complexities of the different furlough schemes so necessary to retain some of our staff. This process has not been without its challenges in meeting deadlines and amending errors, and so in early 2021 we hope to make some improvements.
