This category shall be available only fo new members, and will last only for a period of 12 months or until the commencement of the next full membership year whichever may be the longer. Full membership will then be applied. Fees shall be pro-rata for any interim period. Holders will not be Company Members nor receive Full Member benefits. iii) Family Club Member £200. Two adults in an enduring family relationship, residing at the same address and their children up to the age of 18 years of age will be eligible under this category. This category shall be available only for new members, and will las only for a period of 12 months or until the commencement of the next full membership will then be applied. For a number of years Past Commodores of RTYC have been accorded free membership for life (including spouses). This has become custom and practice but is not included in any provision in the Club's Articles or Rules. At the AGM on 30 January 2022, it was proposed that in recognition of services to the Royal Temple Yacht Club a retiring Commodore should be accorded Full Complementary Membership for the period of one year which then reverts to an annual subscription. The General Committee has considered this proposal and concluded that the practice of free membership for life for past Commodores should cease both for future Commodores and also past Commodores. However some recognition should be made for the responsibility and effort that the Commodore, and spouse where relevant, are required to bear in fulfilling his/her duties during their time in office. The General Committee therefore proposes the following resolution:			
Special Resolution : from the General Committee. That Past Commodores, and spouses where relevant, who have benefitted from free Membership for a period of years exceeding the number of years served as Commodore, shall revert to Full Company Member status, as set out in Resolution 3 above, with effect from 1 October 2022. Recent and future Commodores will continue to benefit from free membership equal to the number of years served, whereafter they shall revert to Full Company Member status. This resolution will constitute an addition to the Rules.
