### TEMPLE TEASER No 70 Who Were These Famous Navigators? FROM STUART CARTER

#### Solution on page 8

- 1. A Venetian merchant and adventurer, who travelled along the Silk Road from Europe to Asia between 1271 and 1295.
- The Portuguese prince has a legendary status in the early stages of European exploration – despite never having embarked on an exploratory voyage himself. His patronage of Portuguese exploration led to expeditions across the Atlantic Ocean and along the western coast of Africa, and the colonising of the Azores and Madeira islands.
- 3. Under the sponsorship of Ferdinand II and Isabella I of Spain, this navigator embarked on 4 voyages across the Atlantic Ocean between 1492 and 1504.
- 4. In 1497, this Portuguese explorer set sail from Lisbon towards India. His voyage made him the first European to reach India by sea, and opened up the first sea route connecting Europe to Asia.
- This Venetian explorer became known for his 1497 voyage to North America under the commission of Henry VII of England. Upon landing in what he called "New-found-land" in present-day Canada – which he mistook for being Asia – he claimed land for England.
- 6. Around 1501-1502, this Florentine navigator renamed the "new World" after himself.
- 7. The first Englishman to circumnavigate the globe in a single expedition from 1577 to 1580.
- 8. A favourite of Elizabeth 1<sup>st</sup>, he was instrumental in the English colonisation of North America, having been granted a royal charter that allowed him to organise the first English colonies in Virginia.
- 9. A British Royal Navy captain, he embarked on ground-breaking expeditions that helped map the Pacific, New Zealand and Australia.
- 10. This man was the first to sail through the Arctic's treacherous Northwest Passage, from 1903 to 1906.

The fleet now began their journey home stopping at Middelburg and then on to Oostende with some boats breaking their passage at Blankenberg.




Blown Away in Browenshaven

Continued from last month's issue ..... For the benefit of our new members who may not be aware of the long, illustrious history of The Royal Temple Yacht Club, and as a reminder to all, we are re-printing for your enjoyment some articles written by our late, much missed, Archivist and former Commodore, DENYS TWEDDELL

#### THESE ARTICLES COMMENCED WHEN THE RTYC MOVED FROM LONDON, WHERE THE CLUB WAS STARTED AT THE TEMPLE STEPS ON THE THAMES, TO RAMSGATE

#### **RTYC TRUSTEES**

The defining Articles relating to the Royal Temple Yacht Club Trustees are the Trust Deed of 6<sup>th</sup> March 1897, the Supplement of 31st Jan 1911, and the Trust Act 1925 together with the Trustee Act 2000.

Originally, our Trustees held the "freehold Club-house with the fixtures and furniture therein" upon trust for the holders of the Debentures who had advanced money to purchase and fit out the Ramsgate Club House. When the Debenture Holdings were wound up in 1917 the ownership passed "upon Trust for the Club" in accordance with the original Deed. It was agreed that "the Club" meant the Full Members of the Club.

It was established in 1959, after consultation with Counsel, that if, at a General Meeting, a majority of Full Members agreed to sell the property, the Trustees had to proceed with their wishes. The important point here is that Property and indeed effects can only be disposed of by agreement of the majority of Full Members at a General Meeting and that the Trustees have the duty to carry out the wishes of the Members.

The Trust Deeds and the Trust Acts define the length of term of Trustees.

"If and so often as any Tree of the Trust Deed and the Supplemental Trust Deed should die or remain out of the United Kingdom for more than 12 consecutive calendar months or desire to be discharged or refuse or become unfit or incapable to act in the trusts thereof then the surviving or continuing trees or trees or exors of last surviving or continuing tree should appoint such other persons or person as shall be chosen by a majority of the regd debenture holders at a meeting convened as provided by the Trust Deed.

The important points here are that Trustees are chosen at a meeting of the Club; accordingly, a new Trustee is chosen by Full Members at a General Meeting. The 1925 Act requires that, in addition, a person be appointed to testify the approbation of the Members and to sign the new Deed with the exiting Trustees and the new Trustee.

There is no special qualification needed for a Trustee, generally speaking Trustees are held to be prudent persons of standing and reputation and able to meet fiduciary responsibilities

The position of Trustee is one of active responsibility. As mentioned, all funds and Property of the Club are vested in the Trustees. The term Property can assume wide interpretation. For example, it embraces Intellectual Property and it could be argued that this extends to preserving the ethos of the Club. Trustees are Guardians of standards and, in a constructive way, they could play an important role in ensuring that decisions taken or actions followed are indeed in keeping with the Rules, ethos and moral obligations of the Club.

#### **RTYC TRUSTEES – THEIR HISTORY**

The purchase of No.6 West Cliff Mansions on 26th March 1896 was financed by means of a loan from the National Provincial Bank. Certain Members were guarantors of the loan; they have not been named but it is possible that they were the later and first Trustees:

> Capt. Charles Vernon Anson, RN (retired) John Humphreys Gretton, Barrister at Law Charles Baker. Auctioneer

A conveyance of the property was made to the Trustees for it to be used as a Club House. The Trustees were to raise money to pay off the loan by the issue of Debentures each of £5, to the value of £3,000.

The Trustees were responsible to, and chosen by, the Debenture Holders, holding their interests in Trust. Originally there was a requirement that they be Flag Officers of the Club; this was waived in 1910 as will be detailed later.

The Trustees leased the Club House and furniture to the Members on 8<sup>th</sup> March 1897, for a term of 20 years at a rent of £285 per annum.

On 14<sup>th</sup> October 1898 Capt. Anson and C. Baker retired and John Henry Clutton and Sir Henry Seymour King joined JH Gretton as Trustees.

On 1<sup>st</sup> February 1906 these Trustees leased the adjoining property No.5 West Cliff Mansions from JH Clutton. – he had bought it on 17<sup>th</sup> September 1903 from Mrs Jesse Paramor for £1,100 ostensibly having in mind that the Club would seek to expand in the future. There was a proviso in the Lease Agreement that the Club could purchase at a future date.

William John Paul Peacock and Leslie William Thomas joined JH Clutton on the retirement of H Seymour King and JH Gretton on 25<sup>th</sup> February 1909. JH Clutton had been elected Commodore in 1907. On the February date the Trustees resolved to purchase No.5 from JH Clutton for £900 to be paid for by Debentures valued at £5 each; this transaction was completed on 8<sup>th</sup> June 1909.

The original Trust Deed required Trustees to be Flag Officers of the Club. A problem arose in that JH Clutton and LW Thomas were standing down as Flag Officers for 1911. Mr Clutton had filled the post of Mayor of Ramsgate for the years 1907, 1908, 1909 and these duties were requiring his constant attention.

In anticipation of the problem, the Debenture Holders, at an Extraordinary Meeting on 11 April 1910, resolved to delete from the Deeds the relevant Clause regarding Flag Officers and in the coming year on 1<sup>st</sup> February 1911 JH Clutton, WJP Peacock and LW Thomas were again named as Trustees.

The Lease of the property and furniture was due to end in 1917, a new Lease for Nos. 5 and 6 was agreed on 28<sup>th</sup> February 1916 at a rent of £285 per annum.

The Club, over the years, had been redeeming Debentures and had set up a Repayment Fund. By 1917 all the Debentures had been redeemed. The freehold of Nos. 5 and 6 West Cliff Mansions together with Furniture were now the property of the Royal Temple Yacht Club, with the Trustees holding all in Trust.
